

Door County Adventure III – July 30-August 2, 2012

Tentative itinerary

- The trip will depart from Freeport's Wal-Mart parking lot at 7 a.m. on July 30 with a rest stop in the Milwaukee area.
- A tour stop is being explored in the Milwaukee/Sheboygan area, with lunch along the way as we travel to Door County
- We will arrive at the Landmark Resort at Egg Harbor mid-afternoon and you can unpack and relax
- Evening dinner options are still being determined, but the first night will be free time
- Activities being scheduled or considered include the ferry ride to Washington Island and the island tour on the Cherry Train, Harbor Lady boat cruise on Green Bay, shopping options, American Folklore Theatre production at Peninsula State Park, private charter tour on Door County Trolley (including lighthouse tour and shuttle to the play), local tours, dinners at Greenwood Supper Club and Nightingale's Supper Club, and more. Free time flexibility will be greater this year.
- We will again have two hospitality suites available for our use, including the roomy adjoining deck overlooking Green Bay where you can watch the beautiful sunsets. We will provide food and beverages, and there will be cards and table games as well
- Two of the mornings will feature the deluxe Captain's Buffet breakfast at the resort, with the option of breakfast at Al Johnson's Swedish Restaurant being explored for the other day
- We will depart for home around 9:30 a.m. on Thursday with stops at the Door Peninsula Winery and Distillery and the adjacent Door County Coffee & Tea Store and Door County General Store. We'll make a lunch stop along the way and arrive in Freeport around 6 p.m.

Reservation Policies

- Deposit of \$100 per person is due within 30 days of reservation being made – failure to do so will result in passengers name(s) dropping to the bottom of the waiting list
- Balance of payment is due on or before April 30, 2012
- Cancellations on or before April 30, 2012 will receive a full refund
- Cancellations after April 30 and prior to May 31 will be assessed a \$100/person cancellation fee
- Cancellations after May 31 and prior to June 30 will be assessed 50% of the trip price per person
- Cancellations after June 30 and prior to July 15 will be assessed 75% of the trip price per person
- Cancellations after July 15 will forfeit the full price of the trip
- Any special refund considerations due to extraordinary circumstances are at the sole discretion of the Stephenson County Farm Bureau.
- Payment should be made by check and mailed to **Stephenson County Farm Bureau, 210 W. Spring Street, Freeport IL 61032-4346**. Please mark "Door County trip" in the memo line.
- Replacements will be drawn from the standby list in the order in which they signed up – those on standby do not need to submit any payment until notified
